## CERTIFICATE OF WATER RIGHT

This is to Certify, That A. C. HOTCHKISS

of Lakeview, State of Oregon has a right to the use of

the waters of Crooked Creek and Juniper Creek and Willow Creek, tributaries of Chewaucan River

for the purpose of the irrigation of 2533.9 acres of land and stock use under Proof No. 133 and domestic and stock use under Proof No. 134

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Lake County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5, at page 1; that the priority of the right thereby confirmed dates from 1890

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of diversion of 1/25 of a cubic foot per second per acre, and the aggregate quantity set forth in connection with each tract described below; and said rights shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

(Proof No. 133 for the irrigation of 1388.7 acres of land from Crooked Creek and Juniper Creek) 80 acres in the West half of Northwest quarter and 80 acres in the West half of Southwest quarter of Section Thirty-one: 80 acres in the West half of Northwest quarter and 80 acres in the West half of Southwest quarter of Section Thirty: 80 acres in the West half of Northwest quarter and 80 acres in the West half of Southwest quarter of Section Nineteen and 18 acres in the Southwest quarter of Southwest quarter of Section Eighteen, Township Thirty-five South, Range Twenty-one East of Willamette Meridian. 80 acres in the North half of Northeast quarter; 29 acres in the Southwest quarter of Northeast quarter; 40 acres in the Southeast quarter of Northeast quarter; 40 acres in the Northeast quarter of Southeast quarter; 15 acres in the Northwest quarter of Southeast quarter and 30.9 acres in the Southeast quarter of Southeast quarter of Section Thirty-six: 160 acres in the Northeast quarter and 160 acres in the Southeast quarter of Section Twenty-five: 33 acres in the Northeast quarter of Northeast quarter; 5 acres in the Northwest quarter of Northeast quarter; 33 acres in the Southwest quarter of Northeast quarter; 40 acres in the Southeast quarter of Northeast quarter; 15.3 acres in the Southeast quarter of Northwest quarter; 30 acres in the Northeast quarter of Southwest quarter; 12 acres in the Southeast quarter of Southwest quarter; 80 acres in the North half of Southeast quarter; 37.5 acres in the Southwest quarter of Southeast quarter and 40 acres in the Southeast quarter of Southeast quarter of Section Twenty-four, Township Thirty-five South, Range Twenty East of Willamette Meridian. All in Lake County, Oregon.

(Proof No. 134 for the irrigation of 1145.2 acres of land from Willow Creek) 35 acres in the Northeast quarter of Southeast quarter and 80 acres in the South half of Southeast quarter of Section Twelve: 80 acres in the East half of Northwest quarter; 7 acres in the Northwest quarter of Northwest quarter; 27 acres in the Southwest quarter of Northwest quarter; 160 acres in the Southwest quarter; 30.4 acres in the Northeast quarter of Southeast quarter; 1 acre in the Northwest quarter of Southeast quarter and 30.7 acres in the Southwest quarter of Southeast quarter of Section Thirteen, 160 acres in the Northeast

quarter; 80 acres in the East half of Northwest quarter; 40 acres in the Northeast quarter of Southwest quarter; 27.7 acres in the Southeast quarter of Southwest quarter; 80 acres in the North half of Southeast quarter and 80 acres in the South half of Southeast quarter of Section Twenty-three: 7 acres in the Northeast quarter of Northeast quarter; 24.7 acres in the Northwest quarter of Northeast quarter; 7 acres in the Southwest quarter of Northeast quarter; 29.7 acres in the Northeast quarter of Northwest quarter; 80 acres in the West half of Northwest quarter; 24.7 acres in the Southeast quarter of Northwest quarter; 31.3 acres in the Northwest quarter of Southwest quarter of Section Twenty-four, Township Thirty-five South, Range Twenty East of Willamette Meridian, in Lake County, Oregon.

All of the above described lands shall be limited to 3.9 acre feet per acre during each irrigation season, being the period from January 1 to September 30 of each year.

*The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.*
