## CERTIFICATE OF WATER RIGHT

ofc/o John Day, President, P.O. Box 488, MedfordState of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 65.1 acres

for the purpose of

under Permit No. 18531 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 28, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforescid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.41 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWM NEW, Section 13, T. 36 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

Certificate of water right issued to General Development Co. and recorded at page 27274, Volume 19, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 127.3 acres. Subsequently, the right to the use of water appurtenant to 2.0 acres was canceled by order of the State Engineer entered August 23, 1969 and the use of water appurtenant to 27.3 acres and the point of diversion for the irrigation of 32.9 acres was transferred by orders of the State Engineer entered April 27, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to General Development Co.

The rty t to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
