## CERTIFICATE OF WATER RIGHT

This Is to Certify, That NORBERT H. GILLES

of 490 S. Pacific Hwy., Woodburn , State of Ormgon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Senecal Creek irrigation of 18.0 acres

for the purpose of

under Permit No. G-657 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 25. 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.225 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEM SEM as projected within A. Petit DIC 69, Section 19, T. 4 S., R. 1 W., W. M. S. 74°32' E., 51.2 chs. and N. 24° E. 13.4 chs. from S. W. corner of DIC 69.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

17.2 acres SEM SEM Section 19

0.8 acre SW/4 SW/4
Section 20
both as projected within A. Petit DLC 69
T. 4 S., R. 1 W., W. M.

Land on which water is to be used is part of that described as follows: Lots 4 and 5 of Division of John Miller Estate.

Certificate of water right issued to Norbert H. Gilles and recorded at page 27568, Volume 19, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 40.0 acres. Subsequently, the right to the use of water appurtenant to 22.0 acres was canceled by order of the State Engineer entered March 23, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Norbert H. Gilles.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
