under Permit No. 8298 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 25, 1928

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.28 cubic feet per second measured at the point of diversion

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEX SEX, Section 35, T. 7 S., R. 4 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

Certificate of water right issued to E. Clement Horst Co. and recorded at page 11524, Volume 10, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 192.0 acres. Subsequently, the right to use of water appurtenant to 9.6 acres was canceled by order of the State Engineer entered April 30, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to E. Clement Horst Co.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
