## CERTIFICATE OF WATER RIGHT

This is to Certify, That W. B. PARKER

of Paisley, State of Oregon has a right to the use of

the waters of Chewaucan River, a tributary of Abert Lake

for the purpose of the irrigation of 163 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Lake County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5, at page 1; that the priority of the right thereby confirmed dates from 1878

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of diversion of 1/25 of a cubic foot per second per acre, and the aggregate quantity set forth below; and said rights shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

(Proof No. 139 for the irrigation of 30 acres) 20 acres in the Southeast quarter of Northeast quarter of Section Nineteen and 10 acres in the Southwest quarter of Northwest quarter of Section Twenty, Township Thirty-three South, Range Nineteen East of Willamette Meridian, in Lake County, Oregon.

(Proof No. 140 for the irrigation of 20 acres) 5 acres in the Southwest quarter of Northwest quarter and 15 acres in the Southeast quarter of Northwest quarter of Section Nineteen, Township Thirty-three South, Range Nineteen East of Willamette Meridian, in Lake County, Oregon.

(Proof No. 141 for the irrigation of 113 acres) 40 acres in the Southwest quarter of Northeast quarter; 20 acres in the Southeast quarter of Northeast quarter and 20 acres in the Southeast quarter of Northwest quarter of Section Nineteen; 27 acres in the Southwest quarter of Northwest quarter and 6 acres in the Southeast quarter of Northwest quarter of Section Twenty, Township Thirty-three South, Range Nineteen East of Willamette Meridian, in Lake County, Oregon.

All of the above described lands shall be limited to 4.6 acre feet per acre during each irrigation season, being the period from April 1 to September 15 of each year.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
