CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARVEY CROCK

of Pistol River, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pistol River and unnamed stream No. 1

a tributary of Pistol River (Pacific Ocean) for the purpose of irrigation of 19.9 acres and stock use

under Permit No. 29830 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 8, 1964.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second, being 0.22 c.f.s. from Pistol River for irrigation and 0.01 c.f.s. from unnamed stream No. 1 for stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20; NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 28; Lot 4 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 29; T. 38 S., R. 14 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Stock and 5.2 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
5.4 acres Lot 1 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
9.3 acres Lot 2 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
Section 29
T. 38 S., R. 14 W., W. M.

Diversion points located: 620 feet South and 3310 feet West; 270 feet North and 1370 feet West; 160 feet South and 1250 feet East; all from NE Corner, Section 29.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
