Jackson County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby

confirmed dates from 1902:

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.011 cubic foot per second

The point of diversion is located in the NEM NWM, Section 4, T. 36 S., R. 4 W., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

0.65 acre NEW NEW Section 16 T. 36 S., R. 4 W., W. M.

Land on which water is to be used is more explicitly described as follows:

Beginning at the corner common to Sections 9, 10, 15 and 16, Township 36 South, Range 4 West, Willamette Meridian, Jackson County, Oregon; thence South 0°27'00" East between Sections 15 and 16, 80.68 feet; thence South 11°41'30" East, 30.15 feet; thence North 72°39'30" West, 25.0 feet; thence North 88°59'20" West 313.63 feet to the center line of West Evans Creek Road; thence North 21°15'40" East following the center line of West Evans Creek Road, 100 feet, more or less, to the intersection with the line between Sections 9 and 16; thence in an Easterly direction between Sections 9 and 16, 290 feet, more or less, to the point of beginning, less and excepting an existing right of way for County Road, ALSO EXCEPTING THEREFROM any portion lying within the boundaries of Lloyellen Acres as filed August 7, 1964 in Volume 9 of Plats at Page 48, Records of Jackson County, Oregon.

Certificate of water right issued to Jesse W. Hollis and recorded at page 32803, Volume 24, State Rejord of Water Right Certificates, confirms the right to the use of water for irrigation of 7.9 acres. Subsequently, the right to the use of water appurtenant to 7.25 acres domestic and stock use was canceled by order of the State Engineer entered May 20, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Jesse W. Hollis.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
