CERTIFICATE OF WATER RIGHT

This Is to Certify, That RAYMOND and EMALENE MILLER

of Route 1, Box 65, Yoncalla , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Bennett Creek and Unnamed stream

a tributary of Elk Creek irrigation of 67.2 acres

for the purpose of

under Permit No. 28881 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 21, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second, being 0.32 c.f.s. from Bennett Creek and 0.20 c.f.s. from Unnamed stream

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWM NWM, SEM NWM, NWM SWM, all as projected within Scott DLC 38, Section 33, T. 2 S., R. 4 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Umpqua River is more than 525 c.f.s. at tidewater,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Diversion points located: Bennett Creek - 790 feet North and 390 feet East from WM Corner, Section 33; 820 feet North and 550 feet West from center Section 33. Unnamed stream - 650 feet South and 1620 feet West from center Section 33.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
