This Is To Certify, That ORCHARD PARK WATER SUPPLY COMPANY

of 123 Cherry Lane, Albany , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Willamette River domestic use of forty families

for the purpose of

under Permit No. G-4379 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 22, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SE4, Section 31, T. 10 S., R. 3 W., W. M. Well located: 105.7 feet North, 32° 22.9°, East from SE Corner, Lot 9, Block 3, Orchard Park Subdivision.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Tract "B" (1 house)

......Beginning at the Northeast corner of Orchard Park Subdivision as platted in Section 31, of Township 10 South, Range 3 West of the Willamette Meridian and running thence South 89° 44' East along an extension of the North line of said subdivision, 185 feet; thence South 0° 16' West 117.50 feet; thence North 89° 44' West 185 feet to a point, which point is the intersection of the North line of Peach Tree Lane in said subdivision and the East line of said Orchard Park Subdivision; thence North 0° 16' East 117.50 feet along said East line to the place of beginning, in the County of Benton and State of Oregon.....

Tract "C" (2 houses)

......Beginning at the Northeast corner of Lot 11, Block 2, Orchard Park Subdivision in Section 31, Township 10 South, Range 3 West of the Willamette Meridian, Benton County, Oregon; thence South 89° 44' East along the Easterly projection of the North line of said Block 2, a distance of 185.0 feet to a 5/8" iron rod; thence South 0° 16' West parallel to the East line of said Block 2, a distance of 120 feet to a 5/8" iron rod; thence North 89° 44' West 185.0 feet to the Southeast corner of said Lot 11, Block 2; thence North 0° 16' East 120 feet to the point of beginning, containing 0.510 acre.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
