CERTIFICATE OF WATER RIGHT

This Is to Certify, That PHILLIP and DELIA SPERLING

of Route 1, Box 159, Independence , State of Oregon , has made proof to the satisfiction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Luckiamute River

a tributary of Willamette River irrigation of 126.0 acres

for the purpose of

under Permit No. 29447 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 11, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.58 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, as projected within Vanderpool DLC 63, Section 20, T. 9 S., R. 4 W., W. M. Diversion point located: 2530 feet South and 30 feet East from NW Corner, Vanderpool DLC 63.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
