CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. N. LIPPERT

of 4240 Lakeshore Drive, Selma, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two sumps

a tributary of Deer Creek (Illinois River) for the purpose of irrigation of 58.0 acres

under Permit No. G-2555 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 19, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SE $\frac{1}{4}$ NW $\frac{1}{4}$); NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Guest DLC 40, Section 17, T. 38 S., R. 7 W., W. M. Sumps located: 660 feet North and 720 feet West; 1720 feet North and 1940 feet West; both from center Section 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.2 acres	NE $\frac{1}{4}$ NW $\frac{1}{4}$	as projected within Guest DLC 40
20.0 acres	NW $\frac{1}{4}$ NW $\frac{1}{4}$	as projected within Guest DLC 40
16.4 acres	SW $\frac{1}{4}$ NW $\frac{1}{4}$	as projected within Guest DLC 40
3.6 acres	SE $\frac{1}{4}$ NW $\frac{1}{4}$	as projected within Guest DLC 40
10.8 acres	Lot 4 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
