CERTIFICATE OF WATER RIGHT

This Is to Certify, That MIKE KENAGY

of Route 1, Box 122, Hubbard , State of Oregon , has made proof to the satisfartion of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rock Creek

a tributary of Pudding River irrigation of 28.5 acres

for the purpose of

under Permit No. 15406 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 7, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE% NW%, SE% NW%, Section 31, T. 4 S., R. 1 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable retation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre

NW/4 NE/4

1.4 acres SW4 NEV4

9.8 acres NEW NWW

16.7 acres SE% NW%

Section 31

T. 4 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the northeast corner of the northwest quarter of Section 31, T. 4 S., R. 1 E., of the Willamette Meridian, thence South 160 rods; thence West 60 rods; thence North 160 rods, thence East 60 rods to the point of beginning, and containing 60 acres more or less. Being part of the east half of the northwest quarter of Section 31.

Certificate of water right issued to W. G. Kenagy and recorded at page 17035, Volume 14, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 30.0 acres. Subsequently, the right to the use of water appurtenant to 1.5 acres was canceled by order of the State Engineer entered October 30, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to W. G. Kenagy.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
