## CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLYDE E. and IONA A. FARLOW

of 4165 Riverbanks Road, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 19.2 acres

for the purpose of

under Permit No. 20679 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 27, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 8 (SW)4 NW/4), Section 14, T. 36 S., R. 7 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.2 acres NW/4 SW/4

Section 14

T. 36 S., R. 7 W., W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beg. at the ¼ cor. between Secs. 14 and 15, T. 36 S., R. 7 W., W.M., thence S. along the Section line 475.5 ft. to a point where the section line crosses the North line of the old county road; thence S. 61° 30' E. along the Northerly line of the old Co. road 600 ft.; thence S. 67° 04' E. along the Northerly line of the old county road 64l ft., to a point on the old established line of the Alice McAllister property as described in Vol. 33 page 124 and Vol. 72, page 247 of the deed records of Josephine Co., Ore., thence N. 0° 35' E. along said old established line 1000 ft., to the NE Cor. of said property and which point is also the NW Cor. of a parcel of land formerly owned by J.A. Cookey and described in Vol. 4 page 171 of said deed records; thence N. 89° 29' W. to the point of beginning.

This certificate is issued to correct and supersede the certificate issued to George G. King and recorded at page 20158, Volume 14, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
