CERTIFICATE OF WATER RIGHT

This Is to Certify, That **G. W. STRINGER**
212 Park Avenue, Nyssa **AMERICAN FINE FOODS, INC.**
of P. O. Box 460, Payette **Oregon**
State of **Idaho**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Snake River

a tributary of **Columbia River** for the purpose of
irrigation of 108.0 acres

under Permit No. **6742** of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **May 25, 1925**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
1.35 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the Lot 3 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 28, T. 19 S., R. 47 E.,
W. M. Diversion point located: 2560 feet South and 980 feet East from the NW
Corner, Section 28.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

G. W. Stringer Lands: 35.2 acres Lot 3 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
4.5 acres Lot 2 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
