CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES M. SCHULTZ

of Route 2, Box 226A, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Mill Creek (Pudding River) for the purpose of irrigation of 4.6 acres

under Permit No. G-2027 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 8, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SE¼ SE¼), Section 6, T. 5 S., R. 1 W., W. M. Well located: 600 feet North and 610 feet East from the SE Corner, Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.6 acres Lot 1 (SE¼ SE¼)
Section 6
T. 5 S., R. 1 W., W. M.

Certificate of water right issued to Vera J. Seime and recorded at page 33980, Volume 26, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 27.3 acres. Subsequently, the right to the use of water appurtenant to 22.7 acres was canceled by order of the State Engineer entered December 3, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Vera J. Seime.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
