**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** OAK HILL POTATO FARMS  
BY JULIUS GEHRING, JR.

of Route 3, Box 98, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream and reservoir constructed under Application No. R-42812, Permit No. R-4794

a tributary of Beaver Creek for the purpose of supplemental irrigation of 6.4 acres

under Permit No. 31521 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 2, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.074 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SE $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 17, T. 7 S., R. 1 W., W. M. Diversion point located 2590 feet South and 1280 feet East from NW Corner, Lot 1 (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4794,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to Oak Hill Potato Farms by Julius Gehring Jr. and recorded at page 36011, Volume 28, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 24.4 acres and the supplemental irrigation of 6.4 acres. Subsequently, the right to the use of water appurtenant to 24.4 acres was canceled by order of the State Engineer entered July 3, 1970. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Oak Hill Potato Farms by Julius Gehring, Jr.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
