CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRANK A. NORDYKE

of P. O. Box 206, Corvallis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two unnamed drainage ways and four reservoirs constructed under Application No. R-43557, Permit No. R-5002

a tributary of irrigation of 40.0 acres

for the purpose of

under Permit No. 32576 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 cubic foot per second, being 0.38 c.f.s. from west drainage way and three reservoirs and 0.12 c.f.s. from east drainage way and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWM NEM, Section 23; SWM SEM, Section 14, both as projected within Grimsley DLC 52, T. 12 S., R. 6 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per scre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permit No. R-5002,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
