CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLENDON L. ANDREWS and MAXINE B. ANDREWS

of Route 2, Box 54, Molalla , State of Oregon 97038, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Molalia River

a tributary of Willamette River

for the purpose of

irrigation of 250.0 acres under Permit No. 27909 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 22. 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.78 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SWA NWA), Section 14, T. 5 S., R. 2 E., W. M. Diversion point located: 1390 feet South and 850 feet East from NE Corner, Wright DIC 39.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
