CERTIFICATE OF WATER RIGHT

This Is to Certify, That EARLE E. SOUDAN

of 3342 McBeth, Napa , State of California , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River, unnamed spring area and reservoir constructed under Application No. R-37978, Permit No. R-3142 a tributary of South Umpqua River for the purpose of irrigation of 67.2 acres

under Permit No. 28319 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 22, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.84 cubic foot per second, being 0.74 c.f.s. from South Umpqua River and 0.10 c.f.s. from unnamed spring area and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEM NWM, NEM SWM; both as projected within O'Neil DLC 38, Section 29, T. 30 S., R. 3 W., W. M. Diversion points located: 650 feet North and 1550 feet East; 730 feet South and 2160 feet East; both from*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-3142; provided further that the right to the use of direct flow is limited to the period when the flow of water in the South Umpqua River is more than 60 c.f.s. at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
