This Is to Certify, That

of Route 2, Box 237, Scio , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Detroit Reservoir constructed under Permit number R-1625 North Santiam River a tributary of for the purpose of supplemental irrigation of 450.9 acres under Permit No. 32521 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 13, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 710.0 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Reservoir - SW/4 NW/4, Section 7, T. 10 S., R. 5 E., W. M. Rediversion pump - NEW SWM, Section 14, T. 9 S., R. 1 W., W. M. Rediversion on North Santiam located - 2630 feet North and 1190 feet West from S¼ Corner, Section 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre, a diversion of 2½ acre feet for each acre irrigated and shall be further limited to a total diversion of not to exceed 710.0 acre feet per year, and is subject to the terms and conditions of contract No. 14-06-100-5815 between the Bureau of Reclamation and the applicant, a copy of which is on file in the Records of the State Engineer;

conform to such reasonable rotation system as may be ordered by the proper state officer.
