**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      **ELDON EVANS**

of 22289 South Molalla Hwy. 213, Oregon City, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Parrott Creek (Beaver Creek) for the purpose of supplemental irrigation of 52.7 acres

under Permit No. G-2454 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 11, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 28, T. 3 S., R. 2 E., W. M. Well located: 640 feet North and 150 feet East from NE Corner, Issac Farr DLC 52.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.6 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
1.0 acre SW $\frac{1}{4}$  NW $\frac{1}{4}$   
15.3 acres SE $\frac{1}{4}$  NW $\frac{1}{4}$   
24.1 acres Lot 4 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
0.6 acre Lot 5 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
6.1 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 28  
T. 3 S., R. 2 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
