CERTIFICATE OF WATER RIGHT

This Is to Certify, That Carl Bethell

of Pt. 2 Box 149 Scio, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork Santiam River, Smallman Creek, main slough and short slough a tributary of Santiam River for the purpose of Irrigation of 235.2 acres under Permit No. 26583 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 10, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.94 cubic feet per second being 0.40 c.f.s. from North Fork Santiam River, 0.20 c.f.s. from Smallman Creek; 1.65 c.f.s from Main slough and 0.69 c.f.s. from short slough.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 34 Section 34, T. 9 S., R. 2 W. M. NE 1/4, NE 1/4, NW 1/4, NW 1/4, Section 3 T. 10 S., R. 2 W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 26 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
