CERTIFICATE OF WATER RIGHT

This Is to Certify, That DONALD LEE and KATHLEEN ROSE BOATWRIGHT c/o Louis A. Mohnike of 3445 N.W. Circle Blvd. Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Alsea River

a tributary of Pacific Ocean irrigation of 25.4 acres

for the purpose of

under Permit No. 15285 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWM NWM, as projected within James Edwards DLC 41, Section 2, T. 14 S., R. 8 W., W. M. Diversion point located: 880 feet North and 2780 feet West from most easterly SE Corner, James Edwards DLC 41.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres SW/ NW/.
10.6 acres SE/, NW/.
8.1 acres NE/. SW/.
3.9 acres NW/. SW/.
all as projected within James Edwards DLC 41
Section 2
T. 14 S., R. 8 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the intersection of the center of Alsea River with the West line of James Edwards Claim #41, T. 14 S. R. 8 W., running thence easterly up center of said river to its intersection with the East line of said claim #41, thence South along the East line of said claim to the most easterly southeast corner thereof, thence West 32.47 chains to interior corner of said claim, thence South along claim line 16.20 chains, thence West 24.28 chains to West line of said claim, thence North along West line of said claim to beginning. Also Lots 4,5 and 6 and the South half of the Southeast quarter of Section 2, T. 14 S., R. 8 W., W. M. all in Benton County, Oregon.

This certificate is issued to supersede certificate of water right issued to H. L Hayden and recorded at page 17129, Volume 14, State Record of Water Right Certificates so as to correctly describe the lands irrigated, and to confirm a change in point of diversion approved by an order of the State Engineer entered December 12, 1968.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
