CERTIFICATE OF WATER RIGHT

This Is to Certify, That D. KOOPMAN, H. D. DUNHAM & C. I. REAM

of Post \_\_\_\_\_, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Crooked River

a tributary of Deschutes River for the purpose of irrigation of 330.0 acres

under Permit No. 320 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 1, 1910

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.13 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SW 1/4, Section 34, T. 16 S., R. 20 E., W. M. Diversion point located: North 18° 50' East 898 feet from SW Corner, Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to \_\_\_\_\_ of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Certificate of water right issued to D. Koopman, H.D. Dunham & C.L. Ream and recorded at page 2010, Volume 3, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 430.0 acres. A change in the right to the use of water for the irrigation of 100.0 acres was approved by order of the State Engineer entered May 24, 1971. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the cert. heretofore issued to D. Koopman, H.D. Dunham & C. L. Ream. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
