CERTIFICATE OF WATER RIGHT

This Is to Certify, That LUKE RYAN

of Medford, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Big Butte Creek

a tributary of Rogue River for the purpose of irrigation of 80.8 acres

under Permit No. E 168 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1913

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.015 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4, NW 1/4 SW 1/4, SE 1/4 SW 1/4, Section 34, T. 33 S., R. 1 E., W. M. SW 1/4 NE 1/4, NW 1/4 SE 1/4, SE 1/4 SE 1/4, Section 3, T. 34 S., R. 1 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to Luke Ryan and recorded at page 3824, Volume 5, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 90.0 acres. A change in the right to the use of water appurtenant to 9.2 acres was approved by order of the State Engineer entered April 2, 1971. This certificate is issued to confirm the remaining right to the use of water for irrigation including changes of points of diversion approved by orders of the State Engineer recorded in Volume 4, page 389, Volume 6, page 23 and Volume 7, page 457, Special Order Records of the State Engineer, and supersedes the certificate heretofore issued to Luke Ryan.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
