

CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HAROLD M. and MARY E. PITT

of Box 200 A North Myrtle Route, Myrtle Creek, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Myrtle Creek

a tributary of South Umpqua River irrigation of 21.3 acres

for the purpose of

under Permit No. 3541 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 24, 1917

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWM NEM, as projected within Browning DLC 41; SWM NEM as projected within Wiley DLC 40; NEM SWM as projected within Wily DLC 40, Section 18, T. 29 S., R. 4 W., W. M. Diversion points located below*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre NE% NE% as projected within Browning DLC 41
9.0 acres SW% NE% as projected within Browning DLC 41
4.2 acres SW% NE% as projected within Wiley DLC 40
1.4 acres SE% NE% as projected within Browning DLC 41
5.6 acres SE% NW% as projected within Browning DLC 41
1.0 acre NE% SW% as projected within Browning DLC 41

* Diversion points located: 1880 feet South and 1400 feet West; 2510 feet South and 2570 feet West; 2820 feet South and 3230 feet West; all from NE Corner, Sec. 18

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered March 10, 1961, and together with certificates confirming other changes supersedes certificate of water right heretofore issued to T. R. Dunnavin and recorded at page 3498, Volume 4, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
