CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHASE GARDENS (A Partnership)

of P.O. Box 509, Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well No. 5

a tributary of Willamette River for the purpose of irrigation of 42.9 acres and commercial

under Permit No. G-1506 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 18, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.40 cubic foot per second, being 0.38 cubic foot per second for irrigation and and 0.02 cubic foot per second for commercial

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Harlow DLC 57, Section 28, T. 17 S., R. 3 W., W. M. Well No. 5 located: 15 chains North and 14.5 chains East from SE Corner, Lot 3

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre Lot 3 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
6.2 acres Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
14.8 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Harlow DLC 57
Commercial and 21.8 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Harlow DLC 57
Section 28
T. 17 S., R. 3 W., W. M.

Certificate of water right issued to Chase Gardens and recorded at page 28971, Volume 21, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 42.9 acres and commercial use from wells No. 2, 4, and 5. Subsequently, the right to the use of water from wells No. 2 and 4 was canceled by order of the State Engineer entered July 23, 1971. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Chase Gardens.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
