## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ZANE MAY

, State of , has made proof of Rt. 2, Dayton Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River a tributary of Columbia River

for the purpose of

irrigation of 80.3 acres under Permit No. 25444 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.01 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (NW/4 NW/4), Section 1, T. 5 S., R. 3 W., W.M. Diversion point located: North 3° 20' East 2250 feet from W/4 Corner, Section 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 6.3 acres Lot 4 (SE% SE%) Section 35 T. 4 S., R. 3 W., W. M.

15.0 acres Lot 8 (NW% NW%) 13.3 acres Lot 7 (SW% NW%) 3.9 acres Lot 7 (SE% NW%) Section 1

23.8 acres Lot 8 (NEW NEW) 18.0 acres Lot 7 (SE% NE%) Section 2 T. 5 S., R. 3 W., W. M.

Certificate of water right issued to Zane May and recorded at page 29002. Volume 21, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 84.5 acres. Subsequently, the right to the use of water appurtenant to 4.2 acres was canceled by order of the State Engineer entered August 9, 1971. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Zane May.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
