## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

CLEAR CREEK RESERVOIR COMPANY

of Route 1, Box 64, Halfway , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clear Creek a tributary of Pine Creek for the purpose of

irrigation of 138.9 acres and supplemental irrigation of 7.2 acres under Permit No. 28549 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 12, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.65 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEM SEM, Section 18; SEM NEM, SEM SEM, Section 19; SWM SWM, Section 29; SEM NEM, NEM, SEM SEM, SEM SEM, Section 30; NEM NEM, Section 31; NWM NWM, SEM NWM, Section 32, T. 7 S., R. 46 E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
