## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That WENDELL E. and MARIE G. BARRETT

of 6103 S.E. Paramenter Ct., Milwaukie , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Kellogg Creek

a tributary of Willamette River irrigation of 0.5 acre

for the purpose of

under Permit No. 29359 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 8, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEW SEW, as projected within O. Kellogg DLC 55, Section 6, T. 2 S., R. 2 E., W. M. Diversion point located: 150 feet South and 530 feet West from NE Corner, O. Kellogg DLC 55.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.4 acre NEW SEW
0.1 acre SEW SEW
both as projected within 0. Kellogg DLC 55
Section 6
T. 2 S., R. 2 E., W. M.

Land on which water is to be used is more explicitly described as follows: Lots 2 and 3, in Block 6, ALDER CREST ACRES, EXCEPT the southwesterly 350 feet to be parallel to and 350 feet northeasterly from the southwesterly boundaries of said lots 2 and 3. ALSO that part of Lot 9, Block 6, ALDER CREST ACRES, lying southeasterly of the northeast prolongation of the northwesterly line of Lot 3 of said Block 6.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
