of Box 228 South Myrtle Route, Myrtle Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream and South Myrtle Creek

a tributary of Myrtle Creek
domestic use of one family and irrigation of 7.8 acres

for the purpose of

under Permit No. 33320 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 31, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.11 cubic foot per second, being 0.01 cubic foot per second for domestic from unnamed stream and 0.10 cubic foot per second for irrigation from unnamed stream with any deficiency in the available supply from the unnamed stream for irrigation\* or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SWM NWM as projected within Stephens DLC 38, Lot 8 (NWM, SWM), Section 22, T. 29 S., R. 4 W., W. M. Diversion points located

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and 1.2 acres SW/ NW/4 as projected within Stephens DLC 38 2.4 acres Lot 8 (SW// NW/4) 4.2 acres Lot 8 (NW/4 SW/4) Section 22 T. 29 S., R. 4 W., W. M.

\*to be made up by appropriation from South Myrtle Creek provided that the total quantity diverted from both sources shall not exceed 0.10 cubic foot per second,

Diversic points located: Myrtle Creek - 170 feet North and 1730 feet East; unnamed & cream - 550 feet South and 1540 feet East; 700 feet South and 1450 feet East; all from SE Corner, Stephens DLC 38.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
