CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. H. PHIPPS

of Midland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed spring and open cut

a tributary of Klamath River for the purpose of irrigation of 52.0 acres

under Permit No. 12104 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 31, 1936;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.65 cubic foot per second measured at the point of diversion,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 1, T. 40 S., R. 8 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 28.5 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
- 20.8 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
- 1.7 acres Lot 2 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)
Section 1
T. 40 S., R. 8 E., W. M.
- 1.0 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 6
T. 40 S., R. 9 E., W. M.

Certificate of water right issued to J. H. Phipps and recorded at page 11667, Volume 10, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 63.9 acres. Subsequently, the right to the use of water appurtenant to 11.9 acres was canceled by order of the State Engineer entered October 27, 1971. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to J. H. Phipps.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
