**CERTIFICATE OF WATER RIGHT**

of        Route 2, Box 365, Eugene                      , State of Oregon        , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Willamette River                      for the purpose of supplemental irrigation of 22.7 acres

under Permit No. G-3986        of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from        February 8, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 11 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 25, T. 16 S., R. 4 W., W. M. "C" Well located: 2280 feet North and 3270 feet West from E $\frac{1}{4}$  Corner, Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.3 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$  as projected within Wilson DLC 38  
3.0 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Wilson DLC 38  
Section 24

0.5 acre NW $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Wilson DLC 38  
0.7 acre Lot 12 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
2.3 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Wilson DLC 38  
8.9 acres Lot 11 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
Section 25  
T. 16 S., R. 4 W., W. M.
