CERTIFICATE OF WATER RIGHT

This Is to Certify, That L. W. and BERTHA BOOTS

of Route 1, Box 433, Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Santiam River

a tributary of Santiam River for the purpose of irrigation of 48.4 acres

under Permit No. 33111 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 26, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.61 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Stringer DLC 40, Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 14, Lot 5 (SE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 11, T. 13 S., R. 1 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
2.2 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Stringer DLC 40
15.5 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Stringer DLC 40
5.2 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Stringer DLC 40
Section 14

0.2 acre SE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Stringer DLC 40
Section 15
T. 13 S., R. 1 W., W. M.

Diversion points located: 2270 feet South and 1030 feet East; 1920 feet South and 1140 feet East; 670 feet South and 1260 feet East; all from SE Corner, Clarke DLC 39.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
