that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second, being 0.225 cubic foot per second from Carolyn Creek and 0.225 cubic foot per second from Bette Creek with any deficiency in the available supply from the creeks to be made up by appropriation from the Mohawk River *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW/4, New/4, Section 26, SE/4 NW/4, NW/4, NW/4, Section 27, T. 15 S., R. 1 W., W. M. Diversion points located below: **

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- * provided that the total quantity diverted from all sources shall not exceed 0.45 cubic foot per second.
- ** Diversion points located: Carolyn Creek 1460 feet North and 950 feet East; Bette Creek - 1180 feet South and 2620 feet West; both from E% Corner, Section 27; Mohawk River - 2290 feet South and 3430 feet West from NE Corner, Section 27.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
