CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDMUND H. DUYCKof 2020 S. W. 325th Avenue, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Dairy Creek

a tributary of Tualatin River for the purpose of irrigation of 50.0 acres

under Permit No. 14968 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 18, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.625 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Job DLC 50, Section 1, T. 1 S., R. 3 W., W. M. Diversion point located: 120 feet North and 1990 feet East from SW Corner, Section 1.The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.8 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
21.2 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
19.0 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered November 18, 1966, and supersedes certificate of water right heretofore issued to Emil H. and Anna H. Duyck, and recorded at page 20587, Volume 15, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
