a tributary of supplemental irrigation of 84.3 acres

for the purpose of

under Permit No. 29098 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby September 12, 1963 confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.11 cubic feet per second, being 0.74 cubic foot per second from "A"; 0.14 cubic foot per second from "B"; 0.15 cubic foot per second from "C"; 0.64 cubic foot per second from "D"; and 0.44 cubic foot per second from "E",

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEM SWM, Section 19, SWM NEM, Lot 1 (NWM NWM), Section 30, T. 7 S., R. 46 E., W. M. Diversion points located: "A" - 30 feet North and 130 feet East; "B" - 50 feet North and 810 feet East; "C"-70 feet North and 1200 feet East; "D" - 230 feet North and 1990 feet East; *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
