CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. ELDON FISHER

of Kellogg Route, Box 108, Oakland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Umpqua River

a tributary of Pacific Ocean for the purpose of irrigation of 54.8 acres

under Permit No. 29666 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 12, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.48 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Lyman L. E. Kellogg DLC 40, Section 32, T. 23 S., R. 7 W., W. M. Diversion point located: 2680 feet West and 3180 feet South from SW Corner, Cooper DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.9 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within John J. Kellogg DLC 41
23.2 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within John J. Kellogg DLC 41
Section 29

1.0 acre NW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Lyman L. E. Kellogg DLC 40
26.4 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within John J. Kellogg DLC 41
1.5 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Lyman L. E. Kellogg DLC 40
1.7 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within John J. Kellogg DLC 41
0.1 acre SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Lyman L. E. Kellogg DLC 40
Section 32
T. 23 S., R. 7 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
