CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM UPDEGRAVE

of Idlewild Star Route, Box 295, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of reservoir constructed under application number R-45863, permit number R-5405,

a tributary of North Umpqua River for the purpose of supplemental irrigation of 73.0 acres

under Permit No. 34063 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 19, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 121.7 acre feet

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 24, T. 26 S., R. 4 W., W. M. Diversion point located: 2450 feet South and 1500 feet East from NW Corner, Foster DLC 43.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre~~, a diversion of 2 $\frac{1}{2}$ acre feet for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed 121.7 acre feet,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
