CERTIFICATE OF WATER RIGHT

This Is to Certify, That H. C. ESPE

of Route 2, Box 236, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of unnamed tributary to Little Pudding River for the purpose of irrigation of 68.3 acres

under Permit No. G-3037 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 10, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Saunders DLC 42, Section 24, T. 6 S., R. 2 W., W. M. Well located: 1850 feet North and 650 feet West from SE Corner, Saunders DLC 42.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.3 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within McCorkle DLC 41

1.8 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within McCorkle DLC 41
