CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALVIN and EDITH V. PHILLIPS

of Box 2950, Holland Loop Road, Cave Junction, State of Oregon, has a right to the use of the waters of Sucker Creek

a tributary of Illinois River for the purpose of irrigation of 42.0 acres, domestic and stock and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Josephine County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volumes 1 & 3, at pages 252 & 395 that the priority of the right thereby confirmed dates from 1857

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.84 cubic foot per second, and that the use of water for irrigation purposes shall be confined to the season April 1st to October 31st of each year;

The point of diversion is located in the NW 1/4 SE 1/4 as projected within Briggs DLC 40, Section 35, T. 39 S., R. 8 W., W. M. Diversion point located below: * A description of the place of use under the right, and to which such right is appurtenant, is as follows:

- 17.2 acres SW 1/4 NE 1/4
0.2 acres SE 1/4 NE 1/4
5.0 acres SE 1/4 NW 1/4
1.3 acres NE 1/4 SW 1/4
18.3 acres NW 1/4 SE 1/4
All as projected within Briggs DLC 40
Section 35
T. 39 S., R. 8 W., W. M.

* Diversion point located: 320 feet West and 940 feet South from NW Corner, Lot 2 (NE 1/4 SE 1/4), Section 35.

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the State Engineer entered November 29, 1965, and together with the certificate recorded at page 33022, Volume 25, State Record of Water Right Certificates, supersedes certificate of water right heretofore issued to A. J. Fulk and recorded at page 7129, Volume 7, State Record of Water Right Certificates.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
