## CERTIFICATE OF WATER RIGHT

a tributary of Willamette River irrigation of 106.1 acres

for the purpose of

under Permit No. G-150 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 28, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.33 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEW NEW as projected within Biham DLC 89, Section 29, T. 5 S., R. 2 W., W. M. Well located: 51 chains South and 15.3 chains East from NW Corner, Douillot DLC 87.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Subsequently, the right to the use of water appurtenant to 3.4 acres was canceled by order of the State Engineer entered February 3, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate here-

tofore issued to Louis Schmerber.
