CERTIFICATE OF WATER RIGHT

This Is to Certify, That GOLDIE WILSON, WILFORD ROCK,
ROBERT L. RULIFSON, MAYNARD DENSON,
DONELL BAILEY, and LEE GOOD

of c/o Robert L. Rulifson, Box 64, Cloverdale, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek

a tributary of Saunders Creek (Nestucca River) for the purpose of domestic use of seven families including the irrigation of lawn and garden not to exceed one-half acre in area, stock and four dairy barns under Permit No. 34572 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 4, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second, being 0.03 cubic foot per second for domestic use, 0.01 cubic foot per second for stock and 0.06 cubic foot per second for dairy barns,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 15, T. 4 S., R. 10 W., W. M. Diversion point located: 1790 feet North and 1880 feet West from SE Corner, NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
