CERTIFICATE OF WATER RIGHT

This Is to Certify, That HILBERT SIN FARMS, INC.

of Route 4, Box 415, Albany , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two wells

a tributary of Willamette River

for the purpose of

irrigation of 114.5 acres

under Permit No. G-4327 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 19, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.43 cubic feet per second being 0.76 cubic foot per second from Well No. 1 and 0.67 cubic foot per second from Well No. 2.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (NE)4 NW), Lot 2 (SW). NW), Section 19, T. 13 S., R. 4 W., W. M. Wells located: Well No. 1 - 1990 feet North and 1370 feet East; Well No. 2 - 330 feet North and 800 feet East; both from W. Corner, Section 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2/2 acre feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.


