irrigation of 132.3 acres under Permit No. 32926 under Permit No. of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 15, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (NW/A NW/A), Section 1, Lot 4 (NW/A SW/A), Section 2, T. 21 S., R. 11 W., W. M., 1270 feet South and 3430 feet East; 2880 feet South and 2470 feet West both from Ny Corner, Section 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall
