## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** U. S. DEPARTMENT OF THE INTERIOR  
BONNEVILLE POWER ADMINISTRATION

of P. O. Box 3621, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Columbia River

a tributary of Pacific Ocean for the purpose of irrigation of 12.3 acres, cooling, domestic (sanitary facilities) in Blk. Eddy and Celilo D. C. Terminal under Permit No. 31064 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 16, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.60 cubic foot per second, being 0.27 cubic foot per second for cooling, 0.31 cubic foot per second for irrigation and 0.02 cubic foot per second for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 31, T. 2 N., R. 14 E., W. M. Diversion point located: 2900 feet North and 540 feet East from SW Corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre NE $\frac{1}{4}$  SW $\frac{1}{4}$   
0.3 acre SE $\frac{1}{4}$  SW $\frac{1}{4}$   
domestic and cooling 0.3 acre NW $\frac{1}{4}$  SE $\frac{1}{4}$   
domestic and cooling 0.1 acre SW $\frac{1}{4}$  SE $\frac{1}{4}$

domestic and cooling 5.3 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$   
domestic and cooling 5.8 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
