## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That VERNON DUYCK

of Route 1, Box 370, Forest Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of drainage ditch and reservoir constructed under application number R-42969, permit number R-4883

a tributary of West Dairy Creek irrigation of 63.3 acres

for the purpose of

under Permit No. 32102 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 27, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NW/4 SW/4), Section 18, T. 1 N., R. 3 W., W. M. Diversion points located: Drain ditch #7 - 1080 feet North and 810 feet East; Reservoir - 760 feet North and 900 feet East; both from ME Corner, Johnson DLC 54.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4883.

conform to such reasonable rotation system as may be ordered by the proper state officer.
