of Box 627, North Plains , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed drainageway and reservoir constructed under application number R-43619, permit number R-4913 for the purpose of a tributary of McKay Creek for the purpose of irrigetion of 675 acres

irrigation of 97.5 acres
under Permit No. 32205 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from May 19, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA SWA as projected within Jackson DLC 47, Section 36, T. 2 N., R. 3 W., W. M., 140 feet North and 850 feet East from most westerly SW Corner, Jackson DLC 47.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4913,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
