## CERTIFICATE OF WATER RIGHT

This Is to Certify, That ESTATE OF ROBERT M. TURNER

of Route 1, Box 77 A, Yamhill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a spring, two unnamed streams and reservoir constructed under application number R-40201, permit number R-4489

a tributary of Haskins Creek (North Fork Yamhill River) domestic use of one family and irrigation of 10.7 acres

for the purpose of

under Permit No. 29989 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

August 24, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.135 cubic foot per second, being 0.09 cubic foot per second from stream #1, 0.04 cubic foot per second from stream #2 for irrigation and 0.005 cubic foot per second from spring for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEK NWA, NEW SWA, both as projected within Davis DLC 50, Section 3, T. 3 S., R. 5 W., W. M. Diversion points located: Spring - 1340 feet North and 1270 feet East; Stream #1 - 1250 feet North and \*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under permit No. R-4489,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

domestic SW/4 NW/4
10.7 acres NE/4 SW/4
Both as projected within Davis DLC 50
Section 3
T. 3 S., R. 5 W., W. M.

\* 1420 feet East; Stream #2 - 680 feet North and 1500 feet East; all from SW Corner, Davis DLC 50.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
