CERTIFICATE OF WATER RIGHT

This is to Certify, That MOLALLA IRRIGATION COMPANY, a corporation

of Molalla, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Molalla River

a tributary of Willamette River for the purpose of Irrigation under Permit No. 204 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 447, on the 15th day of November, 1922; that the priority of the right hereby confirmed dates from December 8, 1909

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 9.26 cubic feet per second, or its equivalent in case of rotation. The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, in or other purposes, the place where such water is put to beneficial use, is as follows: Southwest quarter of Northeast quarter; 29 acres in the Northeast quarter of Northwest quarter; 6 acres in the Northwest quarter of Northwest quarter; 20 acres in the Southwest quarter of Northwest quarter and 36 acres in the Southeast quarter of Northwest quarter; 18 acres in the Northeast quarter of Southwest quarter; 1 acre in the Northeast quarter of Southeast quarter; 24 acres in the Northwest quarter of Southeast quarter; 12 acres in the Southwest quarter of Southeast quarter and 33 acres in the Southeast quarter of Southeast quarter of Section Thirty-three: 16 acres in the Northwest quarter of Southwest quarter and 30 acres in the Southwest quarter of Southwest quarter of Section Thirty-four, Township Four South, Range Two: 6 acres in the Southwest quarter of Northeast quarter; 7 acres in the Northeast quarter of Northwest quarter; 40 acres in the Northwest quarter of Northwest quarter; 20 acres in the Southwest quarter of Northwest quarter; 21 acres in the Northeast quarter of Southwest quarter; 28 acres in the Northwest quarter of Southwest quarter; 30 acres in the Southwest quarter of Southwest quarter and 39 acres in the Southeast quarter of Southwest quarter; 36 acres in the Northwest quarter of Southeast quarter and 14 acres in the Southwest quarter of Southeast quarter of Section Three: 40 acres in the Northeast quarter of Northeast quarter; 24 acres in the Northwest quarter of Northeast quarter and 38 acres in the Southeast quarter of Northeast quarter and 9 acres in the Northeast quarter of Southeast quarter of Section Four: 27 acres in the Northwest quarter of Northeast quarter; 40 acres in the Southwest quarter of Northeast quarter; 34 acres in the Northeast quarter of Northwest quarter; 17 acres in the Northwest quarter of Northwest quarter and 35 acres in the Southeast quarter of Northwest quarter of Section Ten, Township Five South, Range Two: All East of Willamette Meridian, in Clackamas County, Oregon. Containing in all 741 acres of land.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
